This is a summary of the courses that will be offered during 2024. Keep an eye on your email for schedules and announcements.

#### **Fighting Shotgun**

By popular demand, Gregory Cruz is returning to Riverside with his incredible Fighting Shotgun course. Cruz is the premier shotgun instructor in the country. If you own a shotgun, you don't want to miss this course. Learn how to load multiple shells into your shotgun with lightning speed and quickly fire aimed rounds. Learn to load one and shoot, load one and shoot....... These drills are guaranteed to put a major league smile on your face.



#### **Advanced Pistol**

The USCCA DFS1 Course - The USCCA DFS1 course is designed for experienced pistol owners looking to enhance their skills. It delves deep into advanced shooting techniques, concealed carry considerations, and defensive strategies, providing a solid foundation for responsible armed self-defense. Again, this year, Bill Dalpe from the Patriot Firearms School will run this course for us. Bill is an outstanding instructor.

#### **Defensive AR-15 Course**

This course will also be taught by Bill Dalpe from Patriot Firearms School. The defensive AR-15 course is tailored to those who own an AR-15-style rifle. Participants learn how to operate this firearm safely and effectively, with a focus on defensive shooting techniques, marksmanship, and home defense scenarios.



#### The NRA Home Firearm Safety Course

(Massachusetts Firearms Licensing Requirement) - In Massachusetts, prior to owning a firearm citizens must complete a state approved course. After completion of said course, citizens can apply for a Firearms Identification Card (FID) or a License to Carry (LTC). The NRA Home Firearm Safety course when combined with a module which teaches crucial elements of Massachusetts firearm laws is a prerequisite for obtaining a firearms license. This course emphasizes safe handling, storage, and transport of firearms, ensuring that individuals meet the state's stringent firearm laws. Given the ongoing effort by the Massachusetts Legislature to further restrict our Second Amendment rights, every citizen of the state needs to get licensed now before the requirements change for the worse.

#### The NRA Basic Rifle Course

Riverside's own Tony Tufo will be the instructor for this course. It is designed to provide participants with the fundamental knowledge, skills, and attitude necessary for owning and using a rifle safely and effectively. Throughout the course, students will be introduced to various types of rifles, including bolt-action, semi-automatic, and leveraction models, and they will learn how to safely handle, operate, and maintain them. Key topics covered in the course include firearm safety rules, rifle parts and operation, ammunition knowledge, shooting fundamentals, shooting positions, rifle shooting techniques, range rules, cleaning and maintenance procedures, and storage options. The course consists of both classroom instruction and handson shooting exercises conducted under the supervision of NRA-certified instructors. By the end of the course, students can expect to have a comprehensive understanding of rifle safety principles, marksmanship fundamentals, and the confidence to handle rifles responsibly and competently. Whether they are beginners seeking to learn the basics of rifle shooting or experienced shooters looking to refine their skills, participants will gain valuable knowledge and proficiency to become safe and effective rifle enthusiasts.





#### **Tactical Tuesdays**

"Tactical Tuesdays" is a popular weekly tactical handgun advanced shooting session that provides ongoing training and practice opportunities. It covers a wide range of topics, including rapid target acquisition, movement drills, and scenario-based training, allowing participants to continually refine their skills and stay prepared for real-world situations. It is done on the 60 yard range from May through mid-October.

#### **Basic Pistol Skills (3 courses)**

The Basic Pistol Skills program consists of three progressive courses. The first course (Basic Pistol Skills) starts with the very basics. Assuming that the students are new to handguns we must start with the most fundamental skills.

The second course in the series (Basic Pistol Skills Plus) builds on the skills which are developed in the first course. In this course the students work on improving accuracy and begin to work on multiple target engagement.

The third and final course in the series (Beyond Basic Pistol Skills) is advanced shooting. The students continue to work on accuracy and new more complex drills are added to the course curriculum and the students can work on moving around the range and shooting at multiple targets. These courses provide a path for new shooters to learn the skills they need to really become great shooters and feel confident should they decide to take more advanced courses from the great outside instructors that we bring to Riverside.

Although not yet scheduled, we will be setting up:

- NRA Rifle Instructor
- USCCA Concealed Carry and Home Defense
- NTRA Refuse to Be a Victim, First Aid, Stop the Bleed

## Are You Aware

At least half of all people who have a Firearms Identification Care (FID) or a Massachusetts License to Carry (LTC) are not aware that your must inform the state and the local communities when you move. You have 30 days from the date of the move to get it done. We are in really good company on this as the only two categories of people who have to notify the state/city when moving are firearms permit holders and sex offenders. (I can not control myself so I will editorialize now – Gun owners and sex offenders must register. I suspect that many of our legislators would rather have the sex offenders living next door to them then gun owners.)

Be aware that any change of address must be reported. If you move from 1 Main Street, Unit 1 to 1 Main Street Unit 2 in the same town, you must report the change of address. Not reporting your move can prevent you from being able to renew your FID/LTC or even get it suspended.

Fortunately, the Change of Address form is very simple and not a major deal. The information required is at your fingertips.

Unfortunately, the form must be sent by certified mail, although not difficult, it does require a trip to the post office. Make sure that you do not carry your firearms onto post office property as it is a serious offense. The form must be sent to the Firearms Records Bureau, the police department that issued your current license, and the police department of the community you are moving to. Note that as of 2020, you can call the Firearms Records Bureau rather than sending the form in the mail, however since you will be at the post office anyway.....

What if you moved more than 30 days ago and did not send in the form? You should probably do it now. There is a good change that the local police department won't be concerned about the timing so long as they know where you are.

# The Commonwealthof Massachusetts Tramples on Our Rights and Says "Screw You" to the US Supreme Court

Once again, the Massachusetts legislature has decided to fix a problem that does not exist. The Massachusetts legislature will not be satisfied until it completely outlaws firearm ownership in Massachusetts. For the past year they have been working on the most egregious anti civil rights law in the country. This is clearly a temper tantrum by our elected officials who do not like the fact that the Supreme Court in the Bruen case stated that all of the enumerated rights of the Bill of Rights are absolute and that they cannot be "infringed". Prior to this ruling, many in government believe that the Second Amendment is secondary and does not have to be upheld with the same vigor as the other amendments, such as the First Amendment - The right to free speech and the exercise of religion, the Fourth Amendment - prohibiting unreasonable search and seizures, the Fifth Amendment protection against self incrimination and more, the Sixth Amendment - due process. I won't go through them all, but you should get the gist.



The preponderance of the Massachusetts legislature dislikes (many would say loathes) gun owners. They want unarmed society which must rely on the state for protection. We all know how well that works. Gun confiscation is not beyond their final target. You can accuse me of hyperbole. I have read the proposed language, and it is clear: guns and gun owners are *bad* and the Massachusetts legislature must do something about them.

The Gun Owners Action League (GOAL) works tirelessly to stay on top of the proposed legislation and, in the past, has done a remarkable job of preventing the worst language from getting into the new laws. They have even managed some wins but this time, the cards are stacked, the legislature, the Governor, and the White House are aligned against us.



This proposed law is not just insidious and extensive (the GOAL summary of the language is 28 pages – *read it here*), it has been pushed through with no transparency using the most underhanded methods that the legislature can manage. If the law is good, then why the shenanigans?

It is remarkable how so much of the country has been working to enhance the citizens' Second Amendment rights while a handful of states; Massachusetts, New York, California, etcetera are striving to eliminate those rights. Fifty Eight percent that is 29 states now have constitutional or permitless carry of concealed firearms. Among these are our friends to the *north*; Vermont, New Hampshire and Maine. All of these have less violence, including violence using firearms than over-controlled Massachusetts. There is no denying the facts.

Here's the deal. Unless we all stand up for our rights and make phone calls, write letters and challenge the legislature, we will lose our rights. Also, if you are not a member, join GOAL. Don't think that it is not that bad. Read the law, it is the anti-2A wish list. And, make no mistake about it: Not a single life will be saved by this law, but lives will be lost when we are not able to carry to defend ourselves.

This Patriot AR-15 Defensive Shooting class is designed to expose students to an efficient method of defending themselves with an AR-15 during a dynamic critical incident. All of the principles and fundamentals of the USCCA AR-15 Shooting Fundamentals program are applied, and the following topics are covered:

- Four Points of Contact with an AR-15 and Intuitive Shooting Fundamentals
- The Balance of Speed & Precision with an AR-15
- Primary and Secondary Aiming Methods
- Zeroing concepts
- Volume of Fire
- Critical Incident Reloads & Efficient AR-15 Handling
- Fundamental AR-15 Malfunction Clearing

Notwithstanding the eight-hour length, the subject and the shooting in the class, AR-15 defensive shooting class was not a physically challenging course.

# GOAL OUR GOAL IS 100% MEMBERSHIP IN GOAL

The Gun Owners Action League (GOAL) is the official state firearms association in Massachusetts. GOAL is an association of law-abiding citizens who believe that the basic right of firearms ownership.

GOAL works to defend the Constitution and Bill of Rights against those in Massachusetts who wish to infringe upon the freedoms guaranteed by our forefathers.

Now, more than ever, we need to support GOAL and participate in their activities. HD4420 is an incredible attack on our Second Amendment and hunting rights. It has been described as worse than a amalgamation of the worst gun laws from California, New Your and New Jersey. It is a



legislative temper tantrum because our single-party rulers in Massachusetts did not like the Supreme Court's Bruen decision.

If you are not a member of GOAL, you need to join. This organization is the defender of our rights. The Massachusetts legislature just passed a law that essentially allows anyone who is afraid of you because you own guns to file a complaint (valid or not) with the local police and without any hearing or other due process, the police can go to your house and confiscate your guns. The law does not provide a mechanism for you to get them back without an appeal to the court and, even if the complaint is found to be without merit, it can be used as a reason to deny your LTC renewal. This bill ignores all aspects of mental health. The only purpose is to allow the confiscation of our firearms/ removing our rights without due process.

## WHERE CAN I NOT CARRY MY GUN

There are a lot of places where firearms carrying is prohibited by law. (Yes, it has no effect on criminals. But we are law abiding citizens who gleefully follow every government edict.) Let's start with the Massachusetts basics. The following list is extensive but may not hit every prohibitions.

- It is unlawful to possess a firearm on your person on any school grounds; elementary, high school or college. However, if you have written permission of the school board or official in charge, you can have an exception. Good luck with that.
- You may not carry a firearm anywhere on post office property.
- You may not carry a firearm in any federal office building.
- You may not carry a firearm on Army Corp of Engineers property.
- You may not carry on a military base.
- You may carry your firearm in most national parks but not in the visitors' centers.
- You may not carry a firearm in any courthouse all jurisdictions; federal, state, county or local.
- You may not carry a firearm on Massport property. You
  can have an unloaded, properly cased and locked firearm
  on the non-sterile side of an airport for the purpose of
  checking it for a flight.
- You may not carry a firearm if you are under the influence of alcohol or other substances.
- You may not openly carry a shotgun or rifle on a public way unless you are engaged in hunting.
- You may not carry a firearm in a casino.

So that is Massachusetts and some federal guidelines. What are the other rules?

In Massachusetts, does a no guns signs have any legal enforceability? The simple answer is no. However, nothing in Massachusetts is simple. If you are in a private establishment that prohibits firearms you are not breaking any laws, however if the legal occupant (owner/employee) tells you to leave because of your firearm, you must leave. Do not debate, argue, disagree, demand your 2A rights, just shut your pie hole and get out. If you don't, the police will arrest you for trespassing and since you have a firearm, the trespassing misdemeanor skyrockets exponentially to an aggravated charge and you will be spending some time in a 6X9 cinder block accommodation and big bucks on a difficult legal defense.

#### What if you are traveling?

By air – The TSA is very accommodating. They provide the information on their website. In addition, every airline includes detailed information on their websites. The folks at the ticket counter tend to be easy to deal with and will help. Put your unloaded handgun(s) in a good quality hard case with a good lock. Make sure that the case can not be opened more than about 1/8 inch with a lock in place. Keep in your luggage which is to be checked. Do not even think about putting it in your carry-on. If you do put a gun in your carry-on, you deserve what you get.

Go to the counter and tell the agent that you have a gun to check. They will have you show them the case so that they can check it out. They may want you to take the gun out and show that it is in a safe condition, I personally grimace at the thought of displaying a gun in a crowded airport, but, hey, it is their responsibility. You will be instructed to put the case back into your luggage which you will put on the scale, and they will put it on the luggage conveyor. You will also be required to complete a form attesting to the fact that the gun is unloaded. You can also put your ammunition in the luggage. At the other end of your flight, you can collect your luggage when it tumbles off the conveyor belt with all the other luggage. I recommend that, before you walk away, you open your luggage and check that the case is there. I do not recommend opening the case in the airport as there are too many eyes and people who would freak out. Not to mention that you might be breaking local laws about possessing a firearm in an airport.

Note that I only mentioned handguns. It works the same for long guns just the cases are bigger, and they don't go into your luggage.

Also be cautious if you are transporting a "large capacity" gun or magazines, or the dreaded "assault weapons". Make sure that they are legal to possess at the other end of your trip. Once off the plane, you are subject to the whims and crazy gun laws that may exist there. After all, Massachusetts is not the only whacky state.

## WHERE CAN I NOT CARRY MY GUN

*By bus* – Every major long distance bus company prohibits carrying a firearm on their buses. Generally, this includes ammunition and firearm accessories. Some companies will make accommodations for licensed gun owners.

*By cruise ship* – Firearms are prohibited on a cruise ships.

*By train* – It is illegal to carry a firearm on an Amtrack train. If the service has checked baggage, reservations can be made to check guns with your baggage.

By auto/personal vehicle – The McClure-Volkmer Act, otherwise known as FOPA (The Firearm Owners Protection Act), provides protection for those of us who drive to various parts of the country. If you are traveling through a state in which you do not have a firearms license or reciprocity, you can legally transport your firearms across the state. There are caveats; all firearms must be unloaded and cased. The firearms must not be accessible to the passenger compartment. This is very difficult in an SUV but it is possible. You must be simply passing through the state. That means no stopping at tourist attractions or to take a tour. It does not provide protection if you for an overnight stay so get through the unfriendly state and spend the night in a free state.

Another note on FOPA. It only applies to vehicular travel (auto, truck, motor home, motorcycle, etc.). If you are traveling by air and have a connecting flight where you have to take possession of your luggage, make sure that it is in a state where you are licensed or have reciprocity, or even better make the change in one of the 29 constitutional carry states.
