Dear Applicant,

This is to advise you that your application for membership is being processed as quickly as possible. Public Law 91-503 requires that we advise you that a routine inquiry may be made during our initial and subsequent investigation, which will provide applicable information concerning character and general reputation.

Character References are **required** to process your application.

All applications **MUST be submitted by the second Monday of the month** to be prepared in that month. All applicants **MUST appear in person for the first General Meeting** on the third Monday of February, April, June, August, October or December directly following the approval of their application to be voted into the membership. (You may assume approval if we do not contact you) Applicants not able to attend the first General Meeting following the submission of their application for membership are required to submit a written explanation. Applicants who do not appear at the General Meeting; and who have not supplied a letter of explanation, will have their applications deferred to the following meeting. There are **NO EXCEPTIONS** to this membership rule.

Applicants who wish to use Riverside Gun Club's firearm ranges must comply with the **New Member Firearms Qualification Checklist** program detailed on the reverse of this page. Applicants should make arrangements with the Rifle and Pistol Chairperson, at the end of the General Membership Meeting in which you are accepted as a member, to complete this program. This process typically takes approximately 60 minutes. Your KeyCard will not be activated to allow access to the firearms ranges until you have successfully completed this process. **NO Exceptions** to this procedure are allowed.

There will be, typically, a 1 to 3 day delay in the activation of your KeyCard after completion of the procedure.

By Riverside Gun Club By-Laws, no letters or other statements to authorities for the purpose of licensing can be issued without that member having participated in a club sponsored safety training course. Your membership card is your proof of membership.

Remember, it is your responsibility to be familiar with the application process as stated above. Failure to properly comply with this process may result in delay or forfeiture of your application.

Your completed application and payment may be delivered either by mail to the PO Box mailing address shown on the application or dropped off at the club house downstairs bar during regular business hours (M-F 4pm-12pm, Sa & Su noon-12pm).

Cancellation and refund of Membership fee, minus the Initiation Fee, is available within 30days of new Membership approval at the General Membership Meeting or Membership Expiration Date for renewals. No refunds will be granted after 30days.

### **New Member Firearms Qualification Checklist**

#### **INDOOR RANGE**

- UNDERSTANDS SIGN-IN, SIGN-OUT PROCEDURE
- ABLE TO PERFORM RANGE-OPENING PROCEDURES
- KNOWS THE THREE FUNDAMENTAL GUN SAFETY RULES
- UNDERSTANDS THE RANGE CALIBER RESTRICTIONS
- DEMONSTRATES THE ABILITY TO SAFELY LOAD AND UNLOAD A FIREARM
- ABLE TO DESCRIBE THE PROCEDURE FOR HANDLING A MISFIRE, HANGFIRE, OR SQUIB LOAD
- ABLE TO DEMONSTRATE HOW TO CLEAR THE FIRING LINE BEFORE PROCEEDING DOWN RANGE (dropped target, etc)
- DEMONSTRATES THE ABILITY TO PLACE AT LEAST 4 OUT OF 5 ROUNDS ON AN 8 1/2" X 11" SHEET OF PAPER, PLACED AT THE END OF THE 50-FOOT LANE, WHILE IN A SEATED FIRING POSITION
- DEMONSTRATES THE PROCEDURES FOR POST-FIRING CLEAN-UP
- ABLE TO PERFORM RANGE-CLOSING PROCEDURES

#### **OUTDOOR RANGE**

- UNDERSTANDS THE RULES FOR TARGET PLACEMENT ON THE RANGE
- UNDERSTANDS HOW TO CLEAR THE FIRING LINE BEFORE PROCEEDING DOWN RANGE
